### e.g.) John Smith – Digital Camera / Beautiful Mountatins (Halla Mountain)

- 2) All kinds of photos are acceptable. Color, Black and White, Digital or Analog
- 3) Number of works. 3 minimum 5 maximum (picture sequence or a set of pictures are considered as one piece of work)
- 4) Other details

## Digital Camera

- Please upload your photos in official homepage, in JPG file form.
- Original files are required for the 'FINAL ROUND' competitiors.
- Pictures taken with cell phones are allowed to be submitted.

#### Film Camera

- Please scan your original film photos and submit your file. Files should be less then 10MB.
- 5) Please enter the official homepage (<u>www.jejucontest.com</u>). After then, press 'apply' button and complete your application.

## 8. Exclusion from selection and annulment of award decision

a) An entry will not be considered for selection when:

The entry form is not completed and the entrant's information is not clearly written

What is written in the entry form is different from what it really is.

The entrant does not hold the copyright of the photo.

The entrant does not hold a legal drone-related approval from Korean government. It is applied only for those who have submitted drone-pictures.

#### b) An award decision will be cancelled when:

The entrant does not hold the copyright of the photo.

The winning work has been awarded or selected at any other previous competition.

The winning work is found to be a plagiarism of, or closely related to other works.

(Any of the reasons mentioned above could be the cause for the annulment of an award decision, even though the work has already been awarded and could lead to prosecution for the interference in the execution of our duty.)

#### 9. Copyright / Portrait Rights

All rights of prize winning works – such as copyright, property right and the right of use etc. - belong to the organizer.

Contest participants who pass the preliminaries need to submit consent form of possible Copyright /Portrait Rights invasion.(consent form will be sent to the participants separately)

Matters not mentioned in these regulations will be decided by the organizer.

It implies agreement to all conditions and regulations of this article with the submission of the entry form and participation in the competition.
